# **Chairman's Report**

#### 2018 SGUK Awards Ceremony, House of Lords, 28th January 2019

I just wanted to say that the awards ceremony held in the House of Lords on January 28<sup>th</sup> was well worth the effort and all the hard work that the Organisation Team and the Awards Working Party have put in.

The introduction of the Innovation awards section has helped to boost flagging interest over the last few years.

For Innovation, The Lord Cullen Trophy went to Dundee and Angus College for their entry on Asbestos and the involvement of Students in a project which utilised LOcHER concept as a learning tool – further details of the D&A project and LOcHER can be found on our website. As the home group of D&A College, Tayside Integrated Safety Association was also awarded the Albert Porter Rose Bowl. Second place, the SCOS Trophy in the Innovation category went to Celtic Energy from the South and West Wales Safety Group, and third, the Stevenson Shield went to Swansea Council, also members of S&WWSG.

Several entries were categorised as Highly Commended (Grangemouth Contractors Safety Alliance; JSP; NIS; Safe Step and Swansea University) and Commended (Birmingham Environmental Health and Safety Association; Performance Cycling; Qualitek; Swansea Council; TRJ; Welsh Water and Scottish Canals)

This was the first year the Innovation awards were done, and also the first year that those local groups with award schemes of their own were given the opportunity to enter their respective award winners for the SGUK awards.

The previously known Alan Butler Awards, now called the SGUK Excellence Awards was also well supported, with Gold Awards for: Hereford Safety Group; London Safety Group; Northern Ireland Safety Group; South Cumbria Safety Group and South and West Wales Safety Group: The overall best Gold Award Winner is the Northern Ireland Safety Group, who were presented with the Alan Butler Award.

The two chambers were very busy with numerous other tours, all vying to see the grandeur of the building and learn many historic facts.

On completion, we were escorted to the Cholmondley Room passing various MP's dining areas, libraries and committee rooms.

The next part was a drinks reception before being escorted onto the terrace for fine dining. This consisted of: Pumpkin Soup, Guinea Fowl main course, Lemon and Mango dessert followed by coffee and truffles washed down with more wine or soft drinks.

Prior to the meal, Philip White, Principal HSE Inspector; provided an update on the HSE priorities. Further short speeches were provided by our Chairman, Norman Stevenson; Tony Taylor, BT, as Excellence Award Sponsors and Lord Cullen.

Following a short break, Dr Karen McDonnell our Secretary, acted as Master of Ceremonies to announce all the award winners mentioned in the report from our Chairman.

A further break later in the afternoon saw further refreshments along with sandwiches, scones and cakes to be consumed.

Following a closing speech from Norman Stevenson, all present enjoyed a short period of networking or a visit to the Lords shop.

Quite a number of award winners, trustees and visitors then walked slowly up Whitehall, passing the Cabinet Office, Downing Street, The Cenotaph, Horse Guards Parade and other magnificent buildings before stopping just short of Trafalgar Square and congregated in The Lord Moon of the Mall for further celebratory drinks.

All in all, an excellent day which appeared to be enjoyed by everyone spoken to.

#### **Maurice Adamson Award winner:**

#### What winning the Maurice Adamson Award has meant to me?

It's now just a few weeks since I received the SGUK award for outstanding service - 'Maurice Adamson Award' at the House of Lords. It was an amazing start of a very significant and emotional week in my life as I was also retiring from my job as a Health and Safety Inspector at Harrogate on Friday of that week.

In 2004 a group consisting of Businesses, HSE and Local Authority came together and decided there was a desire to help local SME's access relevant information to improve health and safety in their workplaces.

Our aim was to provide 3 Health and Safety events each year which were free of charge and would provide information, training and workshops. My role as part of this group was to make these events happen.

15 years later we are now a recognised Safety Group with delegates regularly travelling from far and wide to attend our events. My personal thanks go out to all the speakers who have given up their time free of charge to support the Forum Group as without them we would not have continued.

Receiving this award was a complete surprise as I had no idea that I had been nominated by the Forum Management Team. I cannot thank them enough for recognising my efforts in making these events happen and to SGUK for selecting me to receive this award.

Even though I am now retired I have decided to remain with the group supporting Businesses to provide Healthy and Safe workplaces for their employees.

#### **Innovation Award Winners:**

#### **Dundee and Angus College: - The Lord Cullen Trophy**

Last year, I was delighted to be invited to and attend the Safety Groups UK Awards for 2017 at the House of Lords. This was my first visit to this prestigious ceremony, and I was impressed with the magnificent surroundings, the organisation of the event and hearing and meeting individuals from numerous organisations throughout the UK, who were all contributing to the 'Helping GB Work Well' strategy that I therefore decided to submit an entry for innovation for the 2018 awards. Never did I envisage that a year later I would be presented with the Lord Cullen Trophy, from the man himself, for the asbestos awareness raising film which was created by employing the LOCHER approach with a group of the Dundee & Angus College's Princes Trust students and their Team Leaders, Jason Beresford and Kerry Hastie.

The process began back in August when I completed the SGUK Innovation entry form and provided a short summary description and supporting information about the asbestos awareness film.

At the beginning of December, I was delighted to receive the news that the entry was through to the next stage and I was invited to make a presentation of the submission to the judging panel at RoSPA's head office in Birmingham.

Jason, Kerry and I made the trip down south to deliver a 15 minutes presentation to support the submission and answer questions by a panel of expert judges. The judges were very supportive and made us feel at ease throughout the process.

A few days later I received the news that the submission had stood out as one of the very best and therefore had won one of the top prizes. This resulted in an invitation to attend the annual SGUK Awards ceremony at the House of Lords in January 2019 during which the final allocation of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place prizes were to be announced after the three finalists had provided the audience with a summary of their entries.

Once again, I was so impressed by the organisation of the event, hearing about the efforts that different groups and organisations are contributing to improve health and safety outcomes including the presentations from fellow finalists Celtic Energy and Swansea Council.

I was overjoyed when it was announced that the film had won the best overall entry and thrilled to receive the Lord Cullen trophy for innovation. I would recommend that organisations who are involved with creative and innovative initiatives to raise health and safety standards consider entering these awards.

The whole day out at the Houses of Parliament was certainly a special one for all four of us who attended and gives the Awards structure a very worthwhile aspirational element.

The new and improved 'products and services are available via the 'Info for Groups' page on the SGUK website and include the items opposite.



# SAFETY ALERT: Change in Enforcement Expectations for Mild Steel Welding Fume

## **HSE Safety Alert issued**

HSE has issued a safety alert about a change in enforcement expectations for mild steel welding fume.

There is new scientific evidence from the International Agency for Research on Cancer that exposure to mild steel welding fume can cause lung cancer and possibly kidney cancer in humans.

The Workplace Health Expert Committee has endorsed the reclassification of mild steel welding fume as a human carcinogen.

With immediate effect, there is a strengthening of HSE's enforcement expectation for all welding fume, including mild steel welding; because general ventilation does not achieve the necessary control.
