

UPDATE FROM THE CHAIR SEPTEMBER 2019

The first meeting of the newly elected Board convened on 23rd September. A lot of work had been done behind the scenes since the AGM in the lead up to the meeting.

He was in my opinion, one of the true unsung heroes of how health and safety has developed. I recall many wonderful things about Mike, and his many stories of how he started in our profession.
